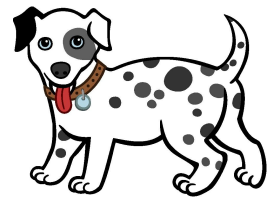

State law requires dogs 5 months of age or older to be licensed each year.
